III. Chief Professional Officer Report - RADM Kelly Taylor

Pleased with attendance given the number of officers deployed. Over 500 PHS officers deployed as of 22 FEB 2020. EHOs are large part of the response.

USPHS Updates:

- At townhall, ASH recently shared vision for 21st century for PHS: always be ready, change the map, meet critical agency needs, and be innovation engines. Slides have been distributed and RADM Taylor strongly advises EHOs to familiarize themselves with information coming from OSG and OASH
- COF: Co-sponsorship agreement with COF has been signed. Please note, if presenting or performing (at ensemble) at COF, officers <u>do</u> need to be agency or COF sponsored
- SG has visited over 19 sites and met with Officers across the US. He noted there are concerns about promotions. If EHOs have concerns or questions about promotion that haven't been answered through the FAQs on website, please reach out to CDR Vaouli (vaouli.elena@epa.gov)
- Officers must still wear ODUs, with limited exceptions. For example, only officers participating in a ceremony (retirement or promotion) can request to wear SDB
- CPOs have evolving role. CPOs are advised to more strategic and less tactical (i.e. be less hands on). RADM Taylor has been advised to help, but also to direct EHOs to CCHQ and agency liaisons if need be.
- PACs are going to be evolving in the future. PACs will likely be taking on projects as directed by the OASH

- Be advised, PHS is undergoing change. Expect more policies, procedures, approvals, and systems being revised. Please be patient and wait for things to settle down and settle out. Talk with PAC and CPO if questions/concerns

VIII. Liaison Reports - CDR Elena Vaouli for CDR Eva McLanahan

Commissioned Corps Headquarters – CDR Robert Horsch

Spoke with eight branch chiefs at CCHQ

- Readiness: February overall EHO readiness was: 97% (7th place); March is 96% (9th place); April is projected to be 91% (9th place)
 - >600 PHS officers deployed. Many EHOs supporting efforts
 - o Important EHOs understand respiratory protection programs, and isolation and quarantine if deployed
 - CCHQ is very focused on maintaining on call schedule. However, there is a chance people will be called outside of on-call month based on the mission
 - Fit testing expected performed before on-site before officer is deployed
- Training
 - OBC starting this weekend. 2 EHOs (OBC 116 has 11 recruits total). Social will be 26 MAR 2020
- Career Management
 - Promotion boards are currently meeting
- Recruitment branch
 - o 11 categories are open. Interested applicants are advised to submit applications online
- Policy
 - Focused on policies impacting officers themselves
- Medical Affairs
 - Periodic Health Update (PHU) is required annually. Be mindful of dates for PHU submission. Info about individual officer's PHU submission date is in the officer secure area. NOTE: It is due by end of the month the individual officer is born in
 - If 5-year physical completed recently, PHU may not be needed. Check officer secure area for more information

American Academy of Sanitarians - CAPT (Ret.) Gary Noonan

- Since last years, interest in AAS from PHS officers. Received applications for and accepted 5 EHOs as members of the AAS. Hope more applications with be continue
- The American Academy of Sanitarians (AAS) is an organization that elevates the standards, improves the practice, advances the professional proficiency and promotes the highest levels of ethical conduct among professional sanitarians in every field of environmental health
 - Academy meets these goals through professional and scholarly activities, mentoring of future EH health leaders, providing scholarships to students in EHAC schools, and continuing to promote leaders in the diverse field of EH
- Bestows the prestigious Calvin Wagner Sanitarian Award. The Award is conferred for exceptional leadership ability, professional commitment, outstanding resourcefulness, dedication and accomplishments in advancing the Sanitarian profession and public health programs
- To be considered for membership:

- Must be a legally registered sanitarian or environmental health specialist in a state or registered by the National Environmental Health Association
- Must possess a master's or higher degree in public health, the environmental health sciences, or in an area of scientific or administrative specialization bearing upon environmental management
- Shall certify profession dedication to protecting and promoting the health and quality of the life of mankind
- At the time of the application, must have at least seven years of acceptable experience in one or more of the various fields of environmental health. Acceptable experience shall include at least five years of full-time work in which the scope of duties was on a professional level with the additional two years (of the total of seven) in a capacity with responsibility for work above the staff level, and
- o Must author a paper that is publishable in a national journal publishable in Environmental Health

 - \circ Several members were not in attendance due to COVID-19 response
