- Readiness
 - Dramatic rise in overall readiness. In April 99.7% readiness. In May 100% compliance with readiness (first time EHOPAC). June readiness is at 100% too.
 - 340 EHOs of 6019 USPHS Officers
 - Readiness of PHU, PFT, and BLS temporarily waived until 30 days post emergency
- Deployment
 - Ongoing and huge undertaking
 - o 1,586 PHS deployments for RDB deploying officers. 2,743 agency deployments.
 - o On-call schedule is not currently active. Maintain readiness and ability to go out the door.
 - Hurricane season has started
 - o Officers supporting tropical storm in LA; COVID; IHS deployments
- Medical
 - o Temporary waiver for 30 days post COVID public health emergency
 - o CAD is being updated. Increase speed for medical clearance for new officers.
 - Medical readiness form sent through secure messaging to some officers.
- Compensation
 - PHS Pay is offline until further notice.

 - Significant number of new hires
 - o Practice hour tracking is operational; may apply to EHOs in the future (but not the near future)
