Readiness - LCDR Steven Merritt

- Waivers are still in place for BLS, APFT, and PHU. Recommend officers do what they can to complete these requirements, if possible, whenever they can during the PHE to prevent falling out of compliance when it ends. Remember that you must contact RDB (via PHSReadiness@hhs.gov or the Readiness Assistance Form) to remove waivers before APFT data can be entered into the RedDOG Self-Service Application. It is likely that the current waivers will be extended beyond the current expiration date of October 2. Will alert the PAC about waiver extensions in coming Readiness Reminders.
- "Safety Officer in a Pandemic" Webinar is rapidly approaching. Will be held on 27AUG20 @ 1400 ET via a 90-minute Adobe Connect session. Information in the most recent Readiness Reminder. 7 EHO presenters are all recently deployed EHOs with a great depth of expertise in the following areas: Hazard Assessment, Mitigation, and Risk Communication; Managing a Respiratory Protection Program; Infection Prevention and Control; Personal Protective Equipment; and Administrative Controls, and Reporting Incidents/Accidents.

- Working with T&E to ensure the AC moderation for the VTS is seamless and several Readiness SC volunteers are working on a Ventilation and IPC presentation in substitute for the Radiation Safety session that would've been a bit less relevant in our current operational environment.
- Reminder that the NDMS Summit in Orlando, FL, the UNMC COVID-19 PPE and Skills Training Courses in Omaha, NE, and the RDB COVID-19 Testing and Contact Tracing Courses in Washington, DC have been postponed or cancelled. Any updates will be pushed out in the EHO Assessment and/or Readiness Reminders.
