Information Technology – CDR Evans

- The old EHO CV, Cover Sheet, and Continuing Education templates were posted to the website. From 1OCT-27OCT the new templates replaced the old templates on the website
- The web team will be focused on making site-wide updates. All SCs should review their content to ensure it is up-to-date and make requests as needed. IT is considering a strategy for streamlining this process across the PAC
- IT has finalized the Needs Assessment and will provide the results as well as a plan of action to the PAC
- End of the year closeout is beginning and will include SC Chair transition and comprehensive updates to the SOP

Marketing and Recruitment – CDR Bales and CDR Kupper

- Recent Actions/Activities -
 - Our AAP workgroup continues to attend the Inter-Pac Recruitment Group meetings monthly
 - M&R leads and the AAP workgroup recently reviewed a combined-PAC proposal to CCHQ for collaboration in the recruitment to the Regular Corps and Ready Reserves. The Proposal breaks down specific responsibilities for CCHQ and PACs during recruitment efforts. The objective is to allow the PACs to act as a force multiplier in recruitment and to be able to have direct interaction once again with candidates.
 - This document was shared with Corps Leadership on 10/25 with hopes of engaging with CCHQ and OSG. Hopefully more to come on this

Mentoring and Orientation – CDR Ferry and CDR Hunter

- M&O received a record number of Mentoring Applications this year
 - o 58 mentoring pair matches were made
 - o 19 unmatched proteges (6 O5s, 13 O4s)
- To prepare both proteges and mentors for the program, we've scheduled the following trainings

- Subcommittee leads are working on Certificates of Appreciation for all mentoring program participants and Thank You letters for subcommittee volunteers.
- M&O requested an Executive Committee meeting with the Career Development to discuss Mentoring Program challenges, requirements, and sustainability
- The OBC Workgroup Structure includes CDR Jessica Pharo leading the OBC Open House and LCDR Kendra Vieira lead the OBC graduation
- M&O is prioritizing updating SOPs for all workgroup subcommittees

Policies and Standards – LCDR Erling

- P&S SC had EHO Survival Guide revision kickoff meeting on 04NOV2021 with CDR Otto and CDR Vaouli. Discussed vision and process for revision. First deliverables due on 01DEC2021 and next meeting scheduled for 03DEC2021.
