
- Last meeting as Chair.

VIII. Executive Committee Liaison Report - CDR Eva McLanahan

- CCHQ Liaison: CDR Robert Horsch has left CCHQ. EC decided not to replace this liaison. Our CPO and PAC Chair will serve as the conduit between CCHQ and the EHOPAC.
- NEHA Liaison: Ms. Jonna Ashley has left NEHA. Replacement to be named in 2022.
- Accomplishments: Anonymous feedback re-established and received over 50 comments from officers; compiled
 comments in preparation for two town halls from over 60 officers; provided SurveyMonkey platform for use for
 M&O, T&E, Awards, and selection of new voting members.
- Looking ahead LCDR Steven Merritt will be the EC Liaison as CDR McLanahan transitions to the Chair of the IT Subcommittee.

Commissioned Officers Association - LCDR James Gooch

- Deadline for to <u>submit symposium abstracts</u> is 15DEC2021, to present 23-27MAY2022 in Renaissance Phoenix Glendale Hotel.
- Recently hosted a four-part Retirement Seminar (<u>check the web</u>).
- Look out for revisions to bylaws, member vote scheduled this winter.
- Continue to focus on <u>legislative priorities</u> for 2021-2022, recent wins:
 - Extension of leave Unlike other services and the federal civilian workforce, CC- USPHS has been unable to extend "use or lose" accrued leave. In 2020, a temporary extension was provided to us via the continuing resolution. Again in 2021, the same language was provided in this year's continuing resolution. Efforts are now underway to make this change permanent so that CC-USPHS can accrue more than 60 days of leave as the other services.
 - DD214/215 Now available for Public Health Service (PHS) officers retiring or separating after October 1. Serves as the discharge certificate or certificate of release from active duty. This has been a barrier for CC-PHS officers in the past when it comes to officially documenting our veteran status. This modernization effort aligns us closer with our sister uniformed services. All Public Health Service officers are highly encouraged to explore and familiarize themselves with the new DD Form 214 platform and instructions. Please refer to the DD Form 214 webinar found on the Learning Management System and the Frequently Asked Questions found on the CCMIS website for additional information. If you have any DD Form 214 specific questions and concerns, please contact your Agency Liaison.

American Academy of Sanitarians - CAPT Wendy Fanaselle

Academy Strategic Planning Committee has been working to update the definition of Sanitarian. It's been 30 years since it has been updated. There's an updated draft definition on the website for anyone to review.

Environmental Health Accreditation Council - CAPT Michael Quinn

- In beginning phases of annual accreditation review cycle. Five programs undergoing review three are reaccreditation (undergrad programs at Baylor, Colorado State, and Ohio University) and two are initial accreditation (Western Kentucky undergrad, Baylor MPH concentration in EH).
- Trying to transition back to on-site or hybrid on-site/virtual visits.
- Working with NEHA to reboot National Environmental Public Health Internship program and how this is marketed to accredited programs. Look for more on this in 2022.
- Reviewing standing of EH programs around the country and institutions planning to seek accreditation. This represented growth in programs and potential widening of pool of candidates.
- EHAC is looking for some practitioners to complete some committee work. Reach out if you are interested.

- Members meet on key subcommittees: Pregnancy, Health & Wellness, Outreach, Anti-Harassment, Recruitment
 & Membership.
- Current Issues include: Deployment challenges, Pregnancy/Infertility & Maternal health related issues, Anti-Harassment & Discrimination, Uniforms and Appearance.
- Resource Guide for USPHS Officers Getting Married or Getting Divorced, and for Dependents Surviving the Death of a USPHS Officer
 - Un-official guide assist in navigating & understanding various policies & resources
 - Topics include: changing your name, enrolling spouse/dependent(s) in benefits, updating Direct Access (Coast Guard), tax considerations, transferring educational benefits/survivor benefits,
 - Prepared by JOAG in collaboration with CCWIAB
