- We are updating the website to reflect new VMs and changes in roles this operational year
- On APAN we are cross referencing volunteer list to make sure officers have access if they do not, let us know. We will be reaching out to the CDR Butler and her team with some questions on the roster
- Would like History and EC to start thinking about what we should do with old items from the website and APAN how do we archive for historical purposes?
- SurveyMonkey will be looking for options since using CDR McLanahan's paid subscription is starting to present challenges with new rules that SurveyMonkey is putting in place

• Marketing and Recruitment – LCDR Erling and CDR Kupper

- M&R Co-Chairs had a meeting with CAPT Jiggens to discuss M&R priorities for 2022. Thank you to CDR Bales for also attending and providing historical perspective of the SC.
- Chairs recently held meetings with three of the four workgroups to discuss work plan for this year and to address some of CAPT Jiggens' recruitment concerns and priorities. Workgroup meeting with M&M pends scheduling for February.
 - Applicant Assistance and Placement Workgroup (AAP)
 - Developing new approaches to assist EHO applicants in finding jobs once boarded. This is in response to CCHQ no longer allowing PACs to reach out to potential officers once they have started the application process.
 - Ideas so far include developing a separate listserv to disseminate information and materials. Also brainstorming the possibility of developing a recruitment forum for applicants to use to solicit advice. Once ideas are finalized, we will share with the EC for comments and approvals.
 - Continues to attend Inter-PAC recruitment meetings to share recruitment related practices/documents among PACs. Last meeting was 4 February 2022.
 - JRCOSTEP Workgroup
 - Tasked to develop innovative ways to reach more students. JRCOSTEP numbers have declined significantly over the last few years. JRCOSTEP is a major recruitment tool for the category.
 - Recruit an EHO (RAE)
 - Updating the recruit an EHO policy document and will be updating the Adopt-a-School university and officer representative list. Will be implementing ways to hold Adopt-a-School representatives accountable.
 - M&R is projecting need for an additional 2-3 subcommittee volunteers.

• Mentoring and Orientation – CDR Ferry and CDR Hunter

- January 2022 OBC 133 had one EHO graduate: LT Justin Rusch, IHS, Fairbanks, AK
- The next OBC 134 Open House is Tuesday, 22FEB2022 from 1350-1510
- We have begun initial internal discussions regarding Career Mentoring at the USPHS COF Symposium in May.
- We are planning a virtual Mentoring Roundtable in Fall of 2022.
- Summary results of the 2020-2021 EHOPAC Mentoring Program Evaluation Survey were discussed. Highlights included:
 - o 96% of respondents indicated that they are willing to continue with the EHOPAC mentoring program
 - Nearly all respondents' expectations were met during the program for career development (94%), career progression (91%), support issues (84%), and personal issues (82%) respectively,
 - o Overall, mentors and proteges rated their communication favorably (Good or Excellent),
 - Over half (54%) of respondents indicated that COVID-19 response work influenced their mentoring work, and
 - o COVID-19 led to richer mentoring discussions and more field experience opportunities.

• Readiness – CDR Bales and CDR Darr

- Volunteer Opportunities We made our selection for volunteers and look forward to bringing them on board. Appreciate the call for volunteers and all efforts that go into it.
- Deployment Skills Webinar ASPR Deployment Skills webinar is still planned and we obtained approval today from CCHQ. We will finalize a date and communication for save the date once we have confirmation to proceed. We continue to work with the Readiness & Deployment Branch presenter in preparation of a future presentation.
- **Readiness Reminder** Upcoming Reminder topics are being prepared. We anticipate there may be some policy updates forthcoming that are related to readiness and will incorporate as soon as able.
- COF Symposium support Pleased to have a SC member participate in the COF Symposium pre-conference clinical skills workshop planning committee. The Deployment Readiness and Clinical Skills event is planned for May 23rd and is led by the Nurse PAC with cross-category participation. We are proposing a skills session that will focus on fit testing and/or PPE donning/doffing procedures. The next planning meeting is on Feb. 17th. As further planning develops, we will provide any critical updates.

• Environmental Justice – CDR Dittrich and LCDR Niman

- WG composition remains the same as last year with the addition of LCDR Butler as our POC to the EC
- WG meets the second Thursday of each month
- Finalizing 2022 workplan with:
 - Recognition that the WG will dissolve after this OY
 - Looking for projects that can be sustained through existing EHOPAC infrastructure
- Selected projects will be shared in future EHOPAC meetings
