 - We often receive inquiries on how to submit a strong application package. Below are a few recommendations:
 - Active participation on an EHOPAC subcommittee as a volunteer
 - Awareness of current EHOPAC activities, initiatives, and priorities
 - Interest in chairing an EHOPAC subcommittee
 - Success as a leader in other organizations (JOAG, COA, NEHA, AIHA, etc.)
 - Strong written commitment (documented in your statement of interest, see below)
 - Willingness to devote a significant amount of personal time to the EHOPAC during your
 3-year term
 - o Timeline:
 - 14JUN22: Announce open seats at General PAC meeting
 - 15JUN22-15JUL22: Solicitation via ListServ and Facebook
 - 29JUL22: Self-nomination packages sent to VMs
 - 09AUG22: Open discussion during business meeting
 - 10AUG22-02SEP22: VMs review and vote
 - 13SEP22: Have votes tallied, announce new VMs at General PAC meeting, via ListServ, and October EHO Assessment
 - 30SEP22: Send appointment packages to OSG
