VII. Executive Committee Liaison Report - LCDR Steven Merritt

- First Step in DD214 Retro Active Application: On 30JUN2022, the House Appropriations Committee, by a vote of 32 to 24, approved the FY'23 Labor, Health and Human Services, Education, and Related Agencies bill. COA was successful in having the report language below included. "Commissioned Corps of the United States Public Health Service. The Committee is aware that as of 01OCT2022 the Commissioned Corps of the U.S. Public Health Service (USPHS Commissioned Corps) is issuing a "Certificate of Release or Discharge from Active Duty" (DD Form 214) to USPHS Commissioned Corps officers who are released from active duty. The Committee requests a report within 90 days of the date of enactment of this Act on the feasibility of issuing a DD Form 214 to each USPHS Commissioned Corps Officer who retired or separated from USPHS Commissioned Corps service prior to 01OCT2022 and received a different statement of service." This is the first step in ensuring a DD214 is available to officers who retired from service prior to 01OCT2022.
