CPO UPDATE

Over the last 40 years the number of Environmental Health Officers (EHOs) has largely waxed and waned in step with the overall size of the Commissioned Corps of the U.S. Public Health Service, which currently stands at approximately 5,700. As the USPHS Commissioned Corps strength has swung from less than 5,500 to nearly 7,000 and back again, our numbers have increased from 278 Sanitarians in 1985 to 386 EHOs in 2009. We have since decreased 18% from that peak to 315 EHOs.

I've heard scuttlebutt that droves of EHOs are taking early retirement because of the Modernization Initiative, but that's not true. There was a spike of deferred early retirements after the COVID stop-loss order was rescinded, but the primary driver for the decrease in our category size has been the large generation before me reaching their 30-year mandatory retirement. Consider that the three CPOs before me all entered active duty within a fifteen-month period in 1990-1991, with RADM Taylor remaining in service beyond 30 years as a flag officer. Our baby boomers have aged out, and this sort of demographic swing is not without precedent. There were over 1,500 medical officers when I was called to active duty, and as this Vietnam-era generation hit 30 years the number of medical officers plummeted by a thousand.

Our accessions remained stable during much of the COVID-era, due to recruiting efforts prior to the Public Health Emergency. However, our recruitment activity slowed greatly during the pandemic, and our pipeline of new EHOs is now nearly empty. We CPOs receive a chart of quad-cleared officer candidates every month or two, and our category is consistently at the bottom because we place all our candidates as soon as they are cleared. We could place many more if we had more candidates. I repeatedly hear from agencies and Commissioned Corps Headquarters that we need more EHOs.

The USPHS Commissioned Corps authorized force strength is 8,000. As the Commissioned Corps begins its recruitment blitz to remedy the service-wide dip in accessions, we could conceivably bring aboard a thousand EHOs before the rest of the categories grow the service to 8,000 strong. I'll settle for 200 new EHOs.

The EHOPAC Recruitment & Orientation Subcommittee Recruitment and Outreach Workgroup is actively recruiting for Council for Education on Public Health (CEPH) and Accreditation Board for Engineering and Technology (ABET) school sponsors and has vacancies for some National Environmental Health Accreditation Council (EHAC) schools as well. Junior EHOs who've come aboard these last few years have classmates at local government or private sector jobs, perhaps searching for more impactful career opportunities. Get out there and start talking to people, the USPHS Commissioned Corps needs more EHOs. After all, we are the foundation of public health and the USPHS Commissioned Corps.

Leadership Perspective

I am a Senior Industrial Hygienist (IH) in the Hazard Evaluation and Technical Assistance Branch (HETAB) of the National Institute for Occupational Safety and Health (NIOSH) in Cincinnati Ohio. NIOSH is the CDC institute charged with preventing work-related illness, injury, disability, and death by gathering information, conducting scientific research, and translating the knowledge gained into products and services.

Since 2014 I have led the NIOSH Nanotechnology Research Centers Advanced Materials and Manufacturing Field Studies Team, assessing health and safety in the production and use of advanced materials and manufacturing such as 3D printing. The team has conducted 45 site assessments, producing informational documents for workers such as "3D Printing with Filaments: Health and Safety Questions to Ask" and contributing to formal guidance such as the NIOSH Current Intelligence Bulletin for silver nanomaterials which set a REL for Silver nanomaterials.

I also supervise a group of HETAB IHs leading multidisciplinary teams (e.g., ergonomists, engineers, and occupational medicine) responding to Health Hazard Evaluation (HHE) requests. An HHE can be requested for any worksite in the U.S. by employees, union representatives, or management with a concern that the work environment may be unsafe. HETAB investigations can take many forms, from a literature review/informational letter to multi day onsite investigations collecting environmental and biological samples as well as observations, questionnaires, or program reviews. I have had the opportunity to complete worker exposure assessments in 45 states, participate in trainings such as the Commissioned

Corps DSAFE program with University of Nebraska Medical Center, and the DARPA Service Chiefs Fellowship Program, as well as 21 emergency response deployments for CDC and USPHS from the 2001 Anthrax attacks to the Southwest Border EIS missions and most recently the East Palestine Train derailment.

I aim to work from a service style, helping people reach their goals, with some visionary style to plan for future goals they have not yet developed. However, its necessary to be comfortable with autocratic leadership both for your team and from those above.

Organization of the Month: ATSDR's Land Reuse and Health Program

<u>The Agency for Toxic Substances and Disease Registry's (ATSDR's) Land Reuse and Health Program</u> helps communities incorporate health considerations in land reuse decisions. People can turn vacant or under-used land into places that benefit the whole area. ATSDR works with the U.S. Environmental Protection Agency (EPA), state and local officials, developers, and communities to include health in these types of projects. As such, through its Land Reuse and Health Program, ATSDR works to conduct the following activities:

- promote a well-rounded approach to redevelopment,
- include health as an important part of redevelopment,
- grow community resources to promote health,
- measure changes in community health,
- encourage early community involvement in decision making,
- restore and revitalize communities in a way that is fair to all community groups,
- promote relationships among, agencies, partners, and communities,
- improve ways to talk about health and environmental risks.
