#### **Mentoring and Orientation:**

The EHOPAC Mentoring and Orientation (M&O) Subcommittee conducted an online survey to evaluate the 2019 mentoring program (Program period Fall 2018-Fall 2019). The survey

included questions to assess communication interactions, mentoring topics, mentoring program resources, and program satisfaction. Below are a few summary points from the one year evaluation survey.

### Characteristics of the Respondents: Diverse agencies, ranks, and experience are represented among mentors and mentees

Survey respondents included 36 mentors and 37 mentees. The majority of the respondents were non-Hispanic or Latino and held the rank of CDR (72%) for mentors and LT (58%) for mentees. Eighty one percent of mentors had at least 11 years of USPHS experience, while 68% of the mentees had less than five years of experience. Fifteen agencies were represented. Most respondents were from either the southeast region or northeast region (73% of mentors and 46% of mentees).

# Communication: Mentoring doesn't take much time, and career development is primary discussion topic

Mentors responded that they communicated with mentees by email, telephone, personal visit, and other methods (e.g., professional forums or NEHA conference).



Figure 1 shows the survey results by discussion topic between mentors and mentees. Career development/progression was the most common.

Sixty-four percent of mentors indicated that they made contact their mentees about 1-2 times per month, while 30% indicated that they made contact less than once every three months. Mentees responded similarly to frequency of contact. Frequently reported discussion topics are shown in the graph. About 58% of respondents attended a formal mentor-training program.

## Program satisfaction: Overall, participants expressed high satisfaction with the program and recommended few areas for improvement

Over 90% of mentors and mentees indicated that communication with each other met their needs. All respondents indicated that they would be willing to serve as a mentor again or continue with their current mentor in the program.

The M&O Subcommittee is planning the following program improvements

- Initiating Mentoring Moment of the Month
- Providing beginning year training and midyear check in webinar
- Revising the Mentoring Topical Guide

#### **Commissioned Corps Headquarters (CCHQ) Updates**

Since the last EHO Assessment edition, the **PHS Ready Reserve Corps** was announced. This <u>Fact Sheet</u> summarizes this exciting time for our service.

The **PHS public-facing website** has a new look! A product of a year-long research, testing and brand development initiative, the new website is a key component of the Commissioned Corps Modernization Initiative. See the new site at <a href="https://www.usphs.gov/">https://www.usphs.gov/</a>. CCHQ welcomes any feedback and invites all officers to take a quick <a href="mailto:survey">survey</a>. Results are anonymous and will help continue to enhance the website.

Because of the critical need for Public Health Service officer expertise and skillsets, the Commissioned Corps will **temporarily pause** both the acceptance of Voluntary Separations/Resignation of Commission and processing of new Voluntary Retirements for officers between 20 to 30 years of active duty service. Any separation/retirement paperwork (PHS-1373) with effective dates between **August 1, 2020 and December 30, 2020** will not be accepted or processed.

CCHQ will make a decision by **October 1, 2020** regarding future requests effective January 1, 2021 and beyond.

CCHQ recently **updated the awards policies**, including a new narrative format, new submissions deadlines, clarifications of awards to wear, and other revisions for clarity and consistency. Individual and Unit awards have resumed.

The new policy can be found on the <u>CCMIS website</u> along with a <u>webinar</u> and <u>frequently</u> <u>asked questions (FAQs)</u> to assist officers in understanding the new changes to the policy. Questions regarding awards should be sent through your liaison and agency awards coordinator.

This includes the <u>Worker Training</u> <u>Program</u>, which provides hazardous materials training courses and tools for many levels of response workers.

Under the Worker Training Program, NIEHS has developed <u>educational resources specific to COVID-19</u>. Their clearinghouse includes PowerPoints, online lessons, fact sheets, and

checklists, many of which are available in both English and Spanish. Topics are targeted to general awareness or specific to essential workers.
