# **Anonymous Feedback System: EHOPAC CV Template**

As we approach promotion season again, there have been questions and comments submitted to the EHOPAC Anonymous Feedback System about the new CV template and whether additional guidance is forthcoming from the EHOPAC about how to use it.

Q: "Last year the EHOPAC notified officers to hold on using the new CV format and that work was underway to develop a more user-friendly version. When can we expect an update on when that will be released? Provide an update to the category on progress and anticipated release date and then post the document on the EHOPAC webpage with a notice sent via the LISTSERV."

A: "The Career Development Subcommittee is working to finalize a user-friendly CV template and guidance to EHOs on how to migrate and translate environmental health career information into the new format. The CV template will be forthcoming before the end of September with some of the preliminary guidance in an EHOPAC LISTSERV message. The guidance document and the template will be posted to the EHOPAC website by mid-October. Career Development is also considering hosting an informational webinar to discuss the CV template, best practices, and answer questions to prepare officers for the upcoming promotion cycle. Please stay tuned to the LISTSERV."

I currently serve as a Team Lead in the CDC/ATSDR Liaison office. I am an advocate for CDC/ATSDR PHS Commissioned Corps officers and provide guidance/advice on Commissioned Corps policies to officers and supervisors. Previously, I served as an Environmental Health Officer in ATSDR's Office of Community Health and Hazard Assessment. In this role I worked with communities that have been impacted from contaminants in their drinking water. I helped give communities a voice and feel heard when the actual contamination is out of their control.

My previous assignments include 5 years with CDC/ATSDR's Liaison office where I assisted the incoming Epidemic Intelligence Service (EIS) officers as they started their CDC fellowship and joined the Commissioned Corps.
