 - a. All categories achieved above 90% readiness for the third quarter in a row.
 - b. The EHOPAC ranked fifth in overall readiness at 93.95%
 - d. Of the 347 EHO Officers, 21 Officers were not qualified, 7 were exempt.
 - e. Of the 21 not qualified Officers, 8 were missing the APFT, 12 were missing BLS, 5 were missing the medical exam, and seven were missing immunizations. Please note that 9 Officers failed to miss basic readiness for multiple reasons.
