### Professional Certifications and Credentials Project (Project Lead: LCDR Tom Peter – Thomas.Peter@fda.hhs.gov)

- Status Update
  - o Discussed with CPO potential of publishing without CCHQ response
  - Waiting from CCHQ to inform CPO about how licensure and credentials are considered in the promotion process.
- Challenges
  - Unclear when CCHQ will provide the information to keep paper as is so moving forward with removing items of concern to hopefully publish paper
- Next milestone
  - Hoping to receive guidance this week from CPO on what information needs to be removed to publish

#### CV Template/Guidance: (Project Lead: LCDR Jake Dyer, <u>Jacob.Dyer@fda.hhs.gov</u>) -

- Status Update
  - Reached out to recently promoted CDRs/CAPTs for CV if they used new template required as of PY2023
  - o Reached out to CCHQ to understand their plan for CV processing
- Challenges
  - o Combined PAC and CCHQ may be working on the same project currently in touch with leadership to prevent redundancies
- Next milestone
  - o Engineer CV Example by mid-November
  - Confirmation on if fillable CV viable option by September meeting





- Questions How many officers from the PY2022 cycle used the new CV Template?
  - o Only two have responded back that they utilized the new CV Template.
  - o The rest utilized a hybrid template.
  - o Not required last year but it will be for the next PY.

#### Promotion Data Analytics (Project Lead LCDR Tim Martin - Timothy.Martin@hhs.gov)

- Status Update
  - The Promotion Data Analytics project is complete. The PY2018-PY2021 Promotion Report was distributed to PHS Engineers Listserv in advance of the CPO Town Hall held on AUG 11.
  - O A continuation project and new team was stood up for Promotion Data Analytics team for a new PY 2022 Promotion Report. A new survey was developed and deployed in JUL & AUG. The survey closed on 8/16, and we received a 67% response rate: 72 out of 108 officers responded, who were eligible for promotion (~140 officers actually up for promotion; not all promotion packets reviewed).
- Challenges
  - None at this time
- Next milestone
  - AUG/SEP: work on Power BI assessments/visuals development & drafting the report.
  - o OCT/NOV plan is to finalize the draft report and route clearance with EPAC leadership.
- Question will future schedule of deliverables consistent with this year?
  - O Some time savings possible; however, it depends on when the promotion results are released.
