

PURPOSE: The RADM Ian K. Burgess Outstanding Young PHS Engineer Award (Burgess Award) recognizes an engineer who is a Junior Commissioned Officer of the US Public Health Service (PHS) that has demonstrated exemplary work as evidenced by specific accomplishments toward the mission of the USPHS Commissioned Corps. This award is named for RADM Ian K. "Ike" Burgess, who served as Chief Engineer from 1975-1985. Nomination for the RADM Ian K. Burgess Outstanding Young PHS Engineer award is an excellent way to recognize the exemplary work of junior engineer officers throughout the USPHS Commissioned Corps.

ELIGIBILITY: All active duty PHS Engineer Officers who hold the rank of O-3 (Lieutenant) or lower upon the date nominations are due are eligible to receive the Burgess Award. Nominees must be in good standing with their assigned agencies, with no current or pending adverse actions on file or under investigation. PHS Officers must also be eligible for awards as determined by the Office of the Surgeon General. Individuals are only eligible to receive the Burgess Award once. In addition, the awardee is ineligible for other individual Chief Engineer or SAME awards for the next full year awards cycle after receipt of the Burgess Award. (i.e. A nominee that receives the Burgess Award solicited in the 2021 Spring Awards Cycle is next eligible for Individual SAME or Chief Engineer Awards during or after the 2022 Fall Awards Cycle). Group or unit awards, such as the SAME Cumming Plaque (Award) or Engineering Literary (ELIT) Awards do not impact Burgess Award eligibility, nor vice versa. There is no limit to the number of nominations from one agency. The Fall Awards Cycle includes the Engineer of the Year (EOY), Engineer Responder of the Year (EROY) and RADM Michael Awards. The Spring Awards Cycle includes all SAME Awards, Lynch, Burgess, Villforth and ELIT Awards.

FORM OF AWARD: The Burgess Award winner shall receive a plaque which will be presented in person during the Engineer Category Day Awards Luncheon at the USPHS Symposium (or equivalent). The Chief Engineer will present an award certificate and/or letter to the awardee, bearing the signature of the Chief Engineer, acknowledging award of the Burgess Award.

SUBMISSION DEADLINE: February 7th at 11:59 p.m. EST

TIMELINE REQUIREMENTS: Nominee activities that were completed during any time period serving as a Junior Engineer Officer of the Commissioned Corps of the US Public Health Service will be considered. Activities that occurred outside of this time period will not be considered. Accomplishments as a civilian or for other uniform services shall not be included in the nomination write-up.

NOMINATION PROCEDURES: Nominees can be either self-nominated or submitted by a nominator.

- 1. One electronic copy of the following documents is required (single PDF):
 - a. Nomination Form, fully signed. Please use attached nomination form (2-pages).

- b. Award nomination <u>narrative</u> which provides a clear and concise description of how the nominee meets the selection criteria (below) and the significant contributions made by a nominee in furthering the mission of not only the Agency to which they are assigned but also the USPHS Commissioned Corps at large. Narratives are limited to a maximum of two single-spaced typed pages (12 point, Times New Roman font), please use attached narrative form document.
- c. CV Cover Page (must follow the current template on the CCMIS Website).
- 2. Nominations must be endorsed (see nomination form for endorsement criteria).
- 3. The nomination packets (nomination form, narrative and CV Cover Page) shall be sent to the current Chair of the EPAC Awards Subcommittee via e-mail as a single PDF attachment (refer to Award Announcement Email or EPAC Website for Chair contact information).

SELECTION CRITERIA: Each nominee must have made outstanding achievements and contributions to the Agency to which they are assigned as well as to the mission of the USPHS Commissioned Corps. The nominee must have demonstrated the ability to accept higher levels of responsibility and leadership in the furtherance of public health. The nominator should focus on the nominee's **impact as it relates to public health** for each of the four criteria. The award will be selected using the following criteria:

- 1. Cited Engineering Achievement, 30 Points.
 - > Level of initiative, innovation and imagination required.
 - > Advancement of state of the art of engineering.
 - Significance of contribution to the solution of an important/difficult problem.
 - Level of improvement in a procedure, policy, or regulation which increases efficiency, reduces cost, saves time, or otherwise contributes significantly to the accomplishment of an important health or engineering objective.
- 2. Support of USPHS Commissioned Corps Mission, 35 Points.
 - > Impact during deployments.
 - Involvement and Leadership in USPHS activities through service on a committee (PACE, COA, EPAC, etc.) or another public health related initiative.
 - > Impact of work on USPHS Mission.
- 3. Consistent Superior Performance in the Accomplishment of Assigned Duties, 25 Points.
- 4. Career Potential, 10 Points.
 - Advancement in career.
 - Performing efficiently in positions of higher responsibility than the nominee's current rank.

1) Complete Nomination Form (2-pages) with all required signatures. Electronic signatures are authorized.

2) Complete 2-page write-up (use attached narrative form document).

3) CV Cover Page (must follow current template on the CCMIS Website).

4) Submit entire package as a single PDF document to the current chair of the EPAC Awards
