#### A Dental Hygiene Officer Pioneer By CAPT Hander and LCDR Melissa Parra

This article was a collaboration between the Dental Professional Advisory Committee and the Health Services Officer Category Dental Hygiene Professional Advisory Group.

CAPT Candace Hander began her government career by enlisting in the U.S. Coast Guard (USCG) in 1983 as

a hospital corpsman and dental technician serving with the USCG for five years. She then attended the Western Kentucky University Dental Hygiene program, earning a bachelor's degree. While there, she served in the



Kentucky Army National Guard/Army ROTC simultaneous membership program, being commissioned as an Army second lieutenant in 1991.

In 1992, CAPT Hander joined the PHS as the seventh dental hygienist to be commissioned. During her first assignment serving the Pine on Ridge Indian Reservation, she served as the Joint Commission coordinator and led the Kyle Health Center through a successful accreditation. While there she embraced the community dental health education component of her position by educating parents in the Women, Infants, and Children (WIC) programs about baby bottle tooth decay (now called early childhood caries) monthly and placing sealants on schoolchildren's teeth during the school year using portable equipment ultimately winning the "super sealer" award. She additionally coordinated all of the pediatric dental health care for Head Start children via the mobile dental unit. Her next assignment was in Sacaton, Arizona on the Gila River Indian Reservation, where in addition to her clinical duties she developed a science project for 8<sup>th</sup> graders on the effect of sucking lemons on their teeth.

In 2003, after receiving her Master of Science from Arizona State University in Environmental Technology Management and Organization Effectiveness, she took a position with the USDA Food Safety and Inspection Service (FSIS) as a Consumer Safety Officer (CSO) Investigator and served in this field position before moving into a training position two years later where she was instrumental in developing the Advanced CSO training program for FSIS. Along the way, she earned her certifications in Reiki, Ayurveda, and as a Yoga teacher. She studied meditation with many teachers and is currently studying with Jack Kornfield and Tara Brach of the Insight Meditation Society.



In 2009 CAPT Hander took a position with the FDA Center for Drug Evaluation and Research (CDER) as a training officer, where she became an International Coaching Federation certified coach. At CDER she instituted the first internal coaching program, taught leadership, networking, communication skills courses, and meditation. In 2017 she partnered with CAPT Indira Harris to create the Resilience Through Meditation program designed virtually to reach officers wherever they might be stationed and provide a basic tool for resilience.

CAPT Hander plans to retire at the end of this year with 29 years of service. Thank you for your service!

# REMEMBERING CAPT CANDACE M. JONES

#### FOR HER WORK IN ESTABLISHING THE DENTAL HYGIENE PROFESSION IN THE USPHS By: CAPT CANDACE Y. HANDER WITH CONTRIBUTIONS FROM MANY OTHERS

CAPT Candace Jones, was instrumental in establishing the dental hygienist profession in the USPHS and the commissioning of baccalaureate dental hygienists. She began her PHS career in 1984 as a contractor with the Southcentral Dental Foundation - an Alaska Native Corporation to provide dental public health services for the Alaska Area of IHS. There she saw the need for providing quality oral health care for the Native American population.

She returned to school in 1987 and received her MPH at the University of Michigan. Upon her return to Alaska in 1988 she was commissioned in the HSO category as a Dental Disease Prevention Officer with the IHS. Prior to 1991, dental assistants, with limited training and experience, provided the majority of cleanings and patient oral health education prior to the commissioning of dental hygienists. Only a few clinical dental hygienists were employed by the USPHS as civilian contractors, and a few – like Candace - who were commissioned with an MPH to do dental prevention work.

In 1988 CAPT Jones began developing the commissioning standards and billets for dental hygienists, meeting with the Alaska Area Dental Officer for IHS, the Chief Dental Officer for IHS and the Special Assistant to the Chief Dental Officer for the USPHS. Once everyone was in agreement, and the needs statement was developed for the RDH discipline within the HSO category of the USPHS. Working with CAPT Donald Schneider, DDS, MPH, Special Assistant to the Chief Dental Officer, CAPT Jones developed the commissioning standards and wrote five billets for dental hygienists. After consulting with the Chief Health Services Officer, the Chief

Dental Officer and the HSO Professional Advisory Committee, the commissioning standards and billets for dental hygienists were sent to the Division of Commissioned Personnel for final evaluation and approval.

The decision to commission clinical dental hygienists at the baccalaureate level was made between September 1989 and August 1991, and the first baccalaureate dental hygienist was commissioned in August 1991. Candace was awarded the USPHS Chief Dental Officer's Exemplary Service Award in 1993 for her efforts.

Between 1992 and 1999 she coordinated an annual continuing education conference for all IHS dental hygienists, and working with a team of others, developed by-laws for the IHS dental hygienist's coalition while serving as its Executive Advisor. She later contributed in organizing the dental hygiene Professional Advisory Group (PAG) in 2005.

In addition to standing up the dental hygiene profession in the USPHS that we know today, she was a warrior for the oral health of American Indian and Alaskan Native children and adults. Over the course of her career she worked on projects like Early Childhood Caries Prevention, the development of a model dental caries diagnosis, risk assessment, and management, Community Support of Water Fluoridation, managing the dental health component of the national IHS Head Start program. She created a model to expand the use of Dental Auxiliaries in IHS, developed HHS department wide oral health initiatives bringing together public and private partners to focus on improving the oral health of underserved children, worked on the Indian Health Care Improvement Act, and coordinated collaboration between the VHA and IHS to improve access and quality of care for Indian veterans.

She was awarded the HHS Secretaries' Award for Distinguished Service for her work as a contributor to the "Oral Health in America: A Report of the Surgeon General", resulting in the publication of Healthy People 2010. Candace also received the IHS Director's Award for outstanding dedication to the prevention of oral disease among AI/AN Presented November 1, 2000, the IHS National Director's Awards for Sustained Quality of Exceptional Performance in Efforts to Improve Oral and Overall Health of American Indian and Alaska Native People Presented December 6, 2001.

In January 2002 she became the Acting Deputy Director, for the Office of Public Health with IHS in Rockville, and in 2006 she moved back to Albuquerque to take the position of National Program Liaison Officer and Acting Director, Division of Clinical and Community Services. Candace finished out her career as the Administrator for the IHS Improving Patient Care program. She retired in 2014 after 26 years of service.

CAPT Candace Jones was a pioneer for Dental Public Health in IHS and she paved the way for the many career dental hygienists in the USPHS today.



## **Fatigue Caused by Dullness**

While cleaning a patient's teeth, have you ever thought to yourself "OMG my hand is really hurting". I am sure you may have thought is it because of the amount of calculus on the patient's teeth but have you ever thought that dull instruments may be the cause. As hygienists, many of us may not like to sharpen our instruments or may not have the time. A study conducted by RDH eVillage newsletter found that 25% of hygienists sharpen their instruments less frequently than once per month, and half of those quarterly or less.<sup>1</sup>

Although the ultrasonic scaler is very efficient for removal of heavy stubborn calculus, hand scaling may still be necessary. While advances in ultrasonic instrumentation now account for much of the periodontal scaling performed, when hand instrumentation is needed, being sharp is critical.<sup>1</sup> Dull instruments make calculus removal more difficult causing more strokes and longer appointment times. Poorly sharpened instruments, the hygienist must grip and push harder on the instrument in order to get it to engage on the tooth. <sup>2</sup> Most of the time, the hygienist's wrist will come out of the neutral position.<sup>2</sup>As hygienists we must realize the impact of how dull instruments can affect our hands. Dental hygienists are known to be at high risk for work-related injuries to their hands.<sup>3</sup> Musculoskeletal disorders (MSD) reported by hygienists are caused by repetitive motion, poor ergonomics, and pushing and gripping the instrument too hard.<sup>4</sup> When hygienists use dull instruments, not only do they have to push harder and grip harder, but when the instrument is poorly sharpened, not sharpened, or incorrectly sharpened, the wrist will come out of the neutral position in an attempt to get the instrument to "bite" the tooth surface.<sup>2</sup> Over time, this repeated action leads to inflammation and injury.<sup>2</sup>

Hygienists must make it a priority to work with sharpen instruments. In order to reduce and prevent work-related hand injuries we must take action by sharpening at the first sign of dullness.

Jones applicants and 6 Junior Dental Hygienist of the Year applicants. The competition was very tough. The Junior Dental Hygienist of the Year was scored on contributions, responsibilities, leadership, and professionalism. The Candace Jones Dental Hygienist of the Year was scored on career progression, award history, leadership attributes, and certifications/continuing education. Current voting members may not apply and you cannot apply for both PAG awards. Here are this year's winners:

#### 2020 Junior Dental Hygienist of the Year: LCDR Cynthia Chennault



LCDR Cynthia Chennault has been a U.S. Public Health Service Commissioned Corps officer for 10 years. After earning her Bachelor of Science Degree in Dental Hygiene from Texas Woman's University in 2008, LCDR Chennault began her career as a LTJG with Indian Health Service (IHS), in Harlem, MT, in 2010. LCDR Chennault served the Gros Ventre and Assiniboine tribes for over two years, establishing a school based sealant and fluoride prevention program. In June of 2012, LCDR Chennault transferred to Rock Hill, SC, where she provided oral health services to the Catawba Indian Nation for over 7 years. LCDR Chennault was a prevention champion at Catawba Service Unit, serving several work groups that led to a 42% reduction in patients achieving smoking cessation and a 53% increase in patients receiving an influenza vaccination. LCDR Chennault authored several grants that established numerous oral health programs within tribal communities. LCDR Chennault is also a national speaker and has delivered several presentations on Health Promotion/Disease Prevention topics. In May of 2019, LCDR Chennault earned a Master's in Public Health and a Graduate Certificate in Emergency Disaster Preparedness from New York Medical College. LCDR Chennault recently accepted assignment with the Health and Resources Service Administration in Rockville, MD. She works in the Division of Medicine and Dentistry—Oral Health Branch, assisting the agency

in improving health outcomes, and addressing health disparities through access to quality services through a skilled health workforce, and innovative, high-value programs. LCDR Chennault has been very active within the Dental Hygiene Professional Advisory Group, the Junior Officer Advisory Group, PHS Athletics, and the Commissioned Officers Association. She has chaired several committees and serves as a role model to other officers. Due to her noteworthy and significant accomplishments as a dental hygienist, LCDR Chennault is strongly deserving of the 2020 Junior Dental Hygienist of the Year Award.

CDR Kelly Moore has served as the Health Services Administrator (HSA) at the Federal Correctional Institution (FCI) Gilmer since July 2019. FCI Gilmer is a Care Level 2 facility operated by the Federal Bureau of Prisons (BOP) in Glenville, West Virginia. She has 25 years of experience working in the healthcare industry. CDR Moore started her BOP career in August 1995 as a Registered Dental Hygienist at FCI Beckley, West Virginia, receiving her commission as an officer with the United States Public Health Service (PHS) on October 2, 1995. In March 2020, she transitioned to HSA at FCI McDowell, a Care Level 1 facility located in Welch, West Virginia. As a trailblazer in her trade, she became the first hygienist to become a HSA for the BOP. She uses her knowledge, skills, and abilities to inspire others to grow in the workplace.




