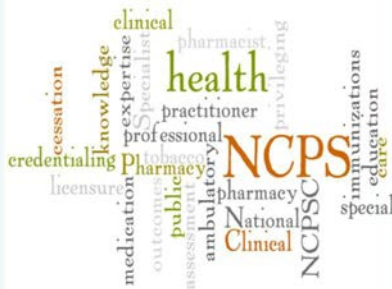

CDR Christina Andrade is a clinical pharmacist stationed with IHSC at Montgomery Processing Center in Conroe, Texas. Utilizing a collaborative practice agreement, CDR Andrade serves as the primary transgender and HIV health care provider to those arriving at her facility. She also works closely with diabetic, hypertensive or hyperlipidemic patients focusing on medical education, pharmacotherapy and therapeutic lifestyle interventions. Since starting in 2017 has had over 3,000 patient encounters, which led to her being recognized as a NCPS-D pharmacist. CDR Andrade also has worked to train and teach oncoming clinical pharmacists for IHSC. IHSC currently has 9 clinical pharmacists – to include CDR Duvivier in Miami, FL, CDR Deborah Long – a full-time infectious disease clinical pharmacist, LCDR Josie Zepeda - a full-time PsychClinical Pharmacist. IHSC's other clinical pharmacists include CDR Kristina Melia, CDR Crystal Madrigal, CDR Stephanie Daniels, LCDR Melody Sun and LT Jordan Burkdoll. For her clinical pharmacy accomplishments, she was awarded IHS's JR Clinical Pharmacist of the year in 2016, PharmPAC Clinical Pharmacist of the Year in 2017 and now has become PHS's first NCPS-D Certified pharmacist. Her consistent dedication and support of clinical pharmacy programming serves as an example in advancing the pharmacy profession.

Sample Patient Encounter Log

Since our transition to a more comprehensive care model, the NCPS Committee has received many questions about the Patient Encounter Log. Here is a sample patient encounter log for your reference. Each practice is different and this log should reflect the vast scope of practice that we are involved in as we innovatively lead pharmacists across the nation.

Encounter	Date	Diagnosis addressed at this encounter
1	x/x/xx	DM2, immunizations, hypothyroidism
2	x/x/xx	DM2, immunizations, CVD, tobacco cessation
3	x/x/xx	Anticoagulation, CVD, immunizations, HTN
4	x/xx/xx	DM2, HTN, immunizations
5	x/xx/xx	DM2, immunizations, CAD, CKD
6	x/xx/xx	Tobacco cessation, DM2, asthma, immunizations

Note: All patient encounters must be within 12 months of applicant submission date. Each encounter must include at least two diagnoses, or one diagnosis and one preventative health intervention.

NCPS members rotate every 3 years. If you are interested in serving on the NCPS you should contact your area pharmacy consultant or your NCPS representative for more information.
