### **CURRENT JOB DESCRIPTION:**

CAPT Thomas is the Lead for the Prevention in Clinical Care Team in the HIV Capacity Building Branch under the Division of HIV/AIDS Prevention at CDC in Atlanta, Georgia. CAPT Thomas provides oversight and guidance to a team of five behavioral and health scientists that disseminate clinical and biomedical interventions and strategies to support sustainable, cost-effective HIV prevention programs in healthcare settings. The team works with national capacity building assistance (CBA) providers and the HIV prevention workforce to incorporate high-impact, HIV-prevention strategies in low economic and high disease burden communities to achieve the goals of the National HIV/AIDS Strategy (NHAS 2020) initiative.

## **QUALIFYING SKILLS FOR CURRENT POSITION:**

Prior to being commissioned in the U.S. Public Health Service, CAPT Thomas served in the U.S. Air Force as a pharmacist for 3 years. In 2001, CAPT Thomas transferred to the USPHS as a regulatory management officer in the Division of Antiviral Products in the Office of New Drugs at the Food and Drug Administration (FDA).

In 2004, CAPT Thomas completed the CDC International Experience and Technical Assistance Public Health Training program. She was detailed to the Botswana Ministry of Health in Gaborone, Botswana to coordinate and organize pharmacy-related activities to support HIV clinical research.

She went on to serve as a senior program management officer consultant in the Division of Antiviral Products at FDA for the President's Emergency Plan for AIDS Relief (PEPFAR)

Program. In 2007, she transferred to CDC's Division of HIV/AIDS Prevention to support prevention program activities including monitoring HIV prevention grants.

Throughout CAPT Thomas's USPHS career, she has had a broad range of professional experiences and published in the area of HIV prevention. She has been recognized for her work through numerous Agency and USPHS awards.
