Authorization of Dental Officer Multiyear Retention Bonus for  
Fiscal Year (FY) 2005

This PPM authorizes the Dental Officer Multiyear Retention Bonus (DOMRB) for FY 2005 (See Attachment of DOMRB Rates). The purpose of the DOMRB is to enhance the ability of the Department of Health and Human Services in retaining qualified dental officers in the Commissioned Corps of the U.S. Public Health Service (Corps). The authorized rates by dental specialty are based upon the retention needs of the Corps.

The rates for the DOMRB approved by this PPM supersede the DOMRB rates contained in Subchapter CC22.2, INSTRUCTION 9. This PPM will remain in effect until September 30, 2005.
