Section A. Purpose and Scope

This INSTRUCTION lists the authorities relating to promotions of PHS commissioned officers and the officials who may exercise these authorities.

33.202	Approve temporary promotion of Regular or Reserve Corps officers to Assistant Surgeon General grades under authority of Section 205(c) of the PHS Act (42 U.S.C. 206(c)).	6/7/77	ASH
33.203	Approve permanent promotion of Reserve Corps officers under authority of Section 203 of the PHS Act (42 U.S.C. 204) and Sections 1(a) and 4 of E.O. 11140.
