## SUBCOMMITTEES

### ***JOAG Journal Subcommittee:***

The *JOAG Journal* Subcommittee is responsible for creating and distributing the *JOAG Journal*. The *JOAG Journal* seeks to provide junior officers with insightful information that is valuable to their lives and careers.

### ***Outreach Subcommittee:***

The Outreach Subcommittee is responsible for recording and transcribing the JOAG educational sessions; updating the official JOAG brochure and presentation; and maintaining a repository of JOAG approved images for junior officers' use to spotlight the important work they do.

### ***Website Subcommittee:***

### ***Tip of the Month Subcommittee:***

This subcommittee solicits topics from members of the Welcoming Committee and then researches and discusses them during bi-monthly teleconferences.

### ***JO Voice Subcommittee:***
